1. Introduction

While Vubis Smart version 2.4.1 was mainly a functional upgrade, the objectives of the Vubis Smart patch 2.4.1.16 are the following:

- ✓ Resolve known outstanding server defects that existed in version 2.4.1 or earlier versions of Vubis Smart;
- ✓ Resolve known outstanding client defects that existed in version 4.102 or earlier versions of the Vubis Smart client;
- ✓ Introduce a selection of smaller functional enhancements.

The 2.4.1.16 patch only delivers and replaces those objects that are directly involved in the defect corrections. Except for the on-line documentation, this is replaced entirely. All other objects and features on an existing installation remain unaffected, and functioning as before.

The 2.4.1.16 patch installs on an existing Vubis Smart 2.4.1.15 version by means of the Vubis Smart Upgrade Wizard, which makes it a straightforward process through a user-friendly Windows graphical user interface.

Please read the 2.4.1.16 upgrade instructions and documentation carefully prior to starting an upgrade to Vubis Smart 2.4.1.16.

2. Migration path to Vubis Smart 2.4.1.16

If you are currently running an older version of Vubis Smart, the migration path to Vubis Smart patch 2.4.1.16 level must be preceded by an upgrade to version 2.4.1.15. There is no straight migration path to patch 2.4.1.16 from pre-2.4.1.15 installations. This patch can only be applied on a system that is already running version 2.4.1.15.

For upgrades to 2.4.1.15 please refer to the 2.4.1.15 upgrade documents and release notes. That process will not be described anymore in this document.

3. Client version compatibility

The recommended version of the Vubis Smart client to run with server version 2.4.1.16 is client build 4.104 (which is made available with patch 2.4.1.16). The minimal client build for this release is 91 for most functions. Minimum level is client build 99 for administrative functions in Acquisitions (AFO272 / Miscellaneous) and in Circulation (AFO469 / Miscellaneous).

4. Release notes for Functional Enhancements

4.1 Enhancements to the Administration of Borrower Replacement Cards

Summary

Basically, two things have been done:

- All replaced barcodes are kept on file, they can be traced and the system prevents the user from using replaced barcodes.
- The lost-card block has been replaced by a replacement reason that goes with barcode replacement.

On the form for barcode replacement, a replacement reason can be entered without yet really changing the barcode. In that case the replacement reason can be undone.

When the barcode is replaced, it is kept on file. The history of replaced barcodes can be seen for each borrower.

Depending on a new parameter the replaced barcode cannot be used anymore.

To prevent the use of replaced barcodes there are new warning messages and error messages throughout the circulation module and also in WebOpac and SIP automated circulation server.

Obviously this has consequences for the transactions file and for the transaction details display in AFO 431.

This new functionality replaces the old lost-card logic. This implies that not only the lost-card blocking but also the lost-card charges move to the new barcode replacement functionality.

The replacement reasons are in a new authority file. The authority list format is enriched with a new field 610 that contains a price flag. Replacement reason goes with barcode replacement

The user can do two things:

- Only fill in a "Reason for replacement".
- Fill in both "Reason for replacement" and "New barcode".

The reasons come from a new authority file (see below)

Case 1: Only fill in a "Reason for replacement"

This can happen for example when the borrower card is reported lost.

This creates the same kind of behaviour as case 2 below. It behaves as a block in AFO 411, 413 etc. (see below). The main difference is that as long as the barcode is not replaced you can undo the "Reason for replacement" by choosing the last option in Reason for replacement:

Transactions

The form above implies to three possible actions = 3 new types of transactions:

- Removal of actual barcode
- Borrower card replacement reason (Card not yet replaced)
- Undo borrower card replacement reason

If this parameter 7 is off, then the following messages are not shown. At initial installation, this option is default ON.

Messages: Warning or blocking

This paragraph applies throughout the circulation system whenever you type a borrower barcode, in particular in the following AFO's: AFO 411, AFO 413, AFO 414, AFO 415, AFO 416, AFO 417, AFO 418 (Per borrower view), AFO 419, AFO 421, AFO 431 and AFO 433.

There are 3 new messages:

These messages also appear when you add a new barcode in AFO 431.

Error or warning?

When you are in AFO 431 and you search for an existing borrower and a valid borrower record can be found, this message is shown as a warning and the system continues with the display of the borrower record.

In all other cases (AFO 411 etc. or when you create a new record in AFO 431) this message is an error message.

Old message

It is not a new functionality that there is an error message when you enter a barcode in AFO431 / New barcode and this is an original barcode that was deleted. It existed as another message:

This message is always still shown, independent of any parameters because it must be impossible to re-use an original barcode.

Messages are also shown when searching on name and the borrower card is IN THE PROCESS OF being replaced.


When you search a borrower by name and the card is in the process of being replaced (reported lost or stolen, for example), the message that the barcode is being replaced is shown as a warning message in AFO 431 or as an error message in the other AFO's.

Blocked also in WebOpac

In the WebOpac there are checks at two places:

(1) At logon, the user is blocked if his barcode is in the process of being replaced.

Example:



(2) Check if barcode has been replaced.

At the point where is checked if a borrower is blocked by the automatic blocks (e.g. at Reservations), a new verification is added that checks if the barcode is not already replaced. This can lead to this blocking message:

"Your card has been replaced. Please consult the library for further information."

SIP

The SIP server for automated circulation also does not yet treat the new replacement functionality in way similar to what is described above. This will be done very soon.



Vubis Smart as per default comes with 3 replacement reasons.

The select list for this new authority list contains a special column "Replacement charge":



The library can add new reasons or change the wording but removal of these three reasons should be discouraged, especially reason 1 because the old lost-card-blocks are converted to this reason 1. (See below)

New field for price flag

A new field has been introduced in the authority list format: field 610, representing the price flag.

This price flag has only two possible values:

1 = a replacement charge has to be paid

0 = no replacement charge.

In fact, any value other than 1 and also the absence of the field leads to no replacement charge.

NOTE: If you were charging for replacement tickets, prior to the upgrade, you will need to ensure that the appropriate replacement reasons are set to 1, in addition to setting the charge in AFO 481 Membership related, Duplicate cards. The default installation will set these values to 0 (no charges).

For editing this new authority, a new template is created and used: "AuthorityList4094". This new template contains only the three fields needed: 100, 600 and 610. Eve

Replace old lost-card logic

The lost-card logic as it existed is now replaced by what has been described in the previous paragraphs. Two things have to be done though: Convert block status = 2 to the new replacement reason and remove the references to "Lost card" on the AFO 431 main screen.

Conversion of old lost-card logic to new lost-card logic

Until now there was a block status with as possible values 0, 1 and 2: 0 = no block 1 = block (this is a block set by library staff) 2 = block because of lost card

Block 2 disappears and is converted to the new replacement code 1. The conversion is done by a terminal program.

If there were more than one block and one of these blocks was 2, this block is removed as well as the system message, because the system message always refers to a lost card block.

AFO 431 cleanup "Lost card"

All references to blocking lost cards must disappear. Texts like "Lost card / blocks" are replaced by "Blocks".

Lost card charges & barcode replacement

So far it worked as follows:

If the library charges borrowers for lost card, this charge was effectuated when the card was reported lost, not when the card was replaced.

There is now a new parameter to enable that the borrower is only charged when the card is really replaced.

This new parameters is here: "Calculate card replacement charges only when new borrower card issued (Institution level setting)" as shown in this form:

Fast User Switch

This allows the user to login again with a new login and password.

If the new user has privileges for the current AFO function (as defined from AFO611) then the current position in the menu is maintained. If not, then the new user will be presented with the top level menu (as if they had just logged in from the beginning). Most other "contextual" information will be retained – for example, the "previous borrower" will be retained from the prior user's session.



In addition this command icon is also offered from any submenu

Although this functionality will only be generally available from a menu, the ability to do this will be specifically added to AFO411 and AFO412 (Checkout and Checkin) since these are the two main functions for which a quick change of user may be relevant.

Fast AFO Switch

The prefix for fast AFO switching is defined in AFO623 Client Settings in the final input box on the screen. It may not be numeric or a single alphabetic character. In the example given "//" is used to introduce a function switch.

From a main AFO menu, the user may simply enter (say) "431" to get to another AFO. In a submenu or a grid listing, entering //431 will swap the user to the new AFO.

In brief, the system behaves as if the user continually presses "Escape" to exit each screen, until the AFO menu or function is reached. However, if an input form is encountered along the way, the function switching is interrupted, since this may require a user intervention.

Finally, if the user enters an invalid AFO number OR one for which they have no permissions, then the command is ignored and treated as regular keyboard input. In general this would then be invalid and will generate a "format error" or similar message, dependent on the context in which this occurs.

Controlling these features

The ability of the system to support these features may be turned off or on from AFO623 (Client interface setting). A few additional, more or less related new features are controlled from this AFO too.

Display staff user name in status bar

If enabled, staff user name is displayed as part of the bottom bar on the client session. The "staff user name" is made available in case extensive use of the fast login leads to confusion as to who is currently logged in.

Display Cache job number in status bar

If enabled, current Cache process id is displayed as part of the bottom bar on the client session. This option is normally provided for Extensity purposes for debugging and testing, but may be useful to end-users too.

Display bib database number in status bar

If enabled, the last accessed bibliographic record id is displayed as part of the bottom bar on the client session. This option is normally provided for Extensity purposes for debugging and testing, but may be useful to end-users too.

Use fast user switch

If enabled, the 'New login' option is enabled on all menu forms. If not enabled, the 'New Login' option is available only from the main menu.

Prefix for fast AFO switching

Define a prefix to indicate 'Jump to new AFO number'. This allows for flexible navigation throughout the system menu structure. For example, a prefix of // may be defined. From a menu, enter //### where number is the AFO desired to call this AFO. Replace the AFO number with 0 to return to the main menu. Examples: //141 to go to SSP or //412 to activate Returns or //0 to return to the main menu. *NOTE: Recommended prefix CANNOT be a keyboard entry used for other functions within the application.*


Require acknowledgements for error messages

If enabled, display error message boxes (recommended setting is ON).

4.3 Receipt location lists

AFO 277 enhancement

AFO 277 has been enhanced with a new menu option "Receipt location lists". These lists are meant to support the functionality for protecting receipt of items for locations other than the local location. This functionality also allows virtual switching of the workstation to a non-local location to allow receipting of non-local items subject to user permissions.



The receipting and invoicing of items ordered for any location will be controlled by use of "receipt location" lists. Each receipt location will have a number of lists containing "valid" locations for selected material types associated with it and only items ordered for these locations and material types may be received and invoiced. The lists will be used to "restrict" the view of copies to be received / invoiced during the receipting/invoicing process of the acquisitions process.

Note that if receipt location lists are not created the receipting and invoicing process will function normally, with no restrictions applied to the data displayed during the receipting and invoicing processes.


